Beekeepers may export under the Animal Products Act 1999 using a Risk Management Programme (RMP) or under the Food Act 2016 using a Food Control Plan (FCP) or a National Programme (NP1 or 3).

- 3 Definitions
  - Supers refer to boxes containing honey.
  - Workplace procedures refer to the policies and procedures set by the employer or organisation on workplace safety, and honey harvesting.
- Workplace procedures must be consistent with the following references –

- 2.4 Remove honey supers from transport vehicle and store.
- 2.5 Maintain and sterilise bee equipment.
