2 Assessment

Evidence for this unit standard must reflect commercial competence; the ability to demonstrate knowledge and skills in the context of the currently accepted requirements of a business operating in a commercial environment.

Evidence must also reflect commercial standards; the verbal and written information covering company policy, standard operating procedures and processes and jobspecific instructions.

This unit standard must be assessed under the supervision of a commercially competent practitioner in workplace conditions that reflect:

- commercial standards, current health, safety, industry, and workplace requirements; and
- industry requirements for commercially acceptable timeframes.

3 Definitions

Joinery work refers to the work, job, or project relevant to joinery, cabinetry, doors and windows, stairs, bench tops and specialty surfaces.

Lead and coordinate refer to daily operations including coordinating the work of other trades, workflow management and completing work within the scope provided without requiring regular guidance and/or scrutiny.

Professional behaviour refers to working constructively with clients and suppliers. Being consistently reliable, responsible, accountable, and acting with integrity is also part of demonstrating professional behaviour. Showing respect and consideration for people, property and the environment while supporting others where required.

Outcomes and performance criteria

Outcome 1

Demonstrate professional standards during joinery work.

Performance criteria

- 1.1 Professional standards are maintained while completing joinery work to a commercially competent standard.
- 1.2 Professional behaviour is maintained throughout joinery work.
- 1.3 Professional standards are demonstrated through self-management of ongoing learning and development and currency with joinery professional standards.
- 1.4 Quality assurance standards are demonstrated in own role and areas of responsibility.
- 1.5 Professional standards of communication are maintained in communicating the production schedule for the joinery work.
- 1.6 Professional standards are maintained in communicating and building relationships with relevant personnel, customers, and the team for the joinery work.

Range communications include – written, oral, graphic, face-to-face.
